1. Confirmation of Agenda

The agenda of the meeting was confirmed with nil amendment.

2. Confirmation of Minutes of Last Meeting

The draft minutes of the meeting held on July 22, 2021 was circulated by email on August 13, 2021 and was confirmed with nil amendment.

3. Matters Arising

3.1 Working Group on Supporting Divorced Families

Ms Angie Chan reported that 2 letters were sent to 葛珮帆議員 and 蔣麗芸議員 regarding the release of Report of HKU's Study on the Phenomenon of Divorce in Hong Kong. Copies of the letters and a reply slip accepting the disclosure of such letters were sent to members for reference as paper 1.

After discussion, members suggested Dr Margaret Wong to invite Prof Daniel Shek to a lunch meeting with Mrs Angela Chiu and Ms Christina Suen to share the views and recommendations of the policy and services for divorced families.

3.2 Working Group on Carer Service and Policy

It was shared that the Task Force has arranged second meeting and invited more representatives from differents NGOs who are operating community carers projects. It would like to sort out the information of service nature, community elements and locations for further analysis. PRA team will help for the execise.

For information, the Council has strong urge on early identification of high-risk carer, eg. middle-aged, unemployed, etc. according to the latest released research. Research and Advocacy team will conduct further study on the enhancement of mainstream respite service.

To advocate the community support for carer, the Council would collaborate with Jockey Club Design Institute for Social Innovation (JCDISI) of the Hong Kong Polytechnic University in coming year. Tentatively, 3 to 9 NGOs will be invited to formulate their ideas and implement the prototype of community support for carer by design thinking approach.

Ms Eliza Lam shared with members that Caritas – Hong Kong operates a display centre for elderly carer at 9/F, Caritas Institute of Higher Education. Agencies are welcome for visitation.

4. <u>CR Review Progress</u>

Paper 2: Guidelines and Procedures for Processing Compassionate Rehousing Cases and Alternative Housing Assistance (recommendations and email message dated August 19, 2021) were sent to members.

Ms Eliza Lam supplemented the background of CR Review. The assessment yardsticks among District Social Welfare Officers (DSWOs) who vet CR cases vary, so a Specialized Team (ST) was suggested before.

To conclude, it was suggested to insist on medical ground should be recommended by public doctors for CR cases. training for IFSCs workers handling CR cases should be followed by SWD recurrently.

5. Mandatory Report System Consultation Paper

Paper 3: (1) Mandatory Reporting System IFSC, Drug & EM service; (2) 強制舉報懷疑虐待兒童個案的規定 - 其他考慮; (3) 香港社會服務聯會就《擬議強制舉報懷疑虐待兒童個案的規定諮詢文件》 交勞工及福利局之意見 was sent to members.

Ms Angie Chan extracted the content in the meeting. It was suggested to request an extension of deadline for such consultation since the service workers wouldn't be ready in such short notice. Moreover, it was agreed that parents, social workers and teachers should have adequate training on the mandatory reporting system before it is in force.

The Family and Community Service Team would explore the possibility in holding professional sharing from lawyers, professors and experienced social workers, with overseas practice referencing in November 2021.
