(1) Introduction of the Council's McKinsey Consultancy Study

- Cliff introduced the McKinsey Consultancy Study to the members of Standing Committee. The staff team of McKinsey had been partnering with the Council to evaluate the strategic directions for upcoming ten years and proposed the strategic blueprint, value, vision and position statement. The adoption of strategic drive on Impact Driven and 3 strategic pillars including Co-creation, Tech-enablement and Talent Development. The infrastructure of the Committees and Networks would be reviewed in alignment with new strategic directions.
- In general, members appreciated the effort to carry out the Consultancy Study and agreed on the directions, particularly the importance of tech enablement and talent development in the sector. After deliberation, members' views were noted, covering importance of participation of cross-sectoral stakeholders and service users, identification and deliberation of agenda in Committee in wider context. HKCSS welcomed further comments from the members after the meeting. The extended governance meeting and agencies meeting would be held in the coming week to discuss the strategies and implementations. Members were encouraged to participate in the meetings.

(2) Confirmation of Minutes of Last Meeting (Appendix 1)

• Minutes were confirmed without any amendment.

(3) Matters arising

(3.1) Anti-epidemic measures and welfare support in combating the epidemic

- Government announced the plan for expanding "vaccine bubble", which would be with effect from 24 Feb. Staff would be required to have received at least one dose of COVID-19 vaccine for entering the scheduled premises regulated under Cap. 599F, as well as other cultural and leisure facilities on 24 Feb, unless providing a medical proof to state that he/she was unfit for vaccination.
- In view of the developments of the pandemic situation, the Government has announced that social distancing measures will be extended to subvented service units until 3 Feb. Various kinds of group activities, including interest classes and talks, and mass programs in all service units will be suspended during the implementation period of the social distancing measures. Service units may consider conducting activities online. Meanwhile, except for visits for official or compassionate reasons, all visiting arrangements for residential care homes for the elderly and residential care homes for persons with disabilities will be suspended.
- Members were alerted that the vaccine bubble might cover home helpers of ELD and REH service, teachers and medical escorts in the coming future.
- Member would clarify with SWD and update members on the second dose vaccination requirement, the definition of "staff" who was required to provide vaccination proof before entering the scheduled premises, and whether cultural and leisure facilities covered community hall. Members also shared that it was not a common practice for WFH arrangement as most services could be maintained.

(3.2) Best Practice Award

• The deadline of application was 24 Jan 2022. 75 applications were received as at 18 Jan 2022. The first-round adjudication and second round interview would be held in March and the award presentation ceremony would be held on 31 Mar 2022 afternoon tentatively. Some members would be invited as members of the judging panel.

(3.3) Mandatory Reporting Requirement for Suspected Child Abuse Cases (Appendix 2)

- The latest progress on the schedule of legislation was updated that the bill on the mandatory reporting would be introduced to LegCo in 2023. SWD is planning to form a multi-disciplinary task force in Feb to work out the details of reporting mechanism and sector's consultation in mid of 2022. In the meantime, SWD has started to explore and prepare the online basic training courses on child protection for all related professionals during the pre-legislation period which the training contents would be based on the existing procedural guide.
- Members suggested that the Commission on Children should be involved in the
 deliberation and preparation of the legislation. Members also raised that the
 Specialized Committee on Family and Community established a working group to
 review the criteria of case reported and the legal aspect of the mandatory reporting.

(3.4) Reorganization of Government Structure

- HKCSS reported on the reorganization of government structure. The reorganization would be effective in the new term government.
- HKCSS submitted a position paper titled "社聯就建議中的青年及地區事務局的職能應否涵蓋青少年福利服務之意見".

(4) Service Focus and Plan 2021-2022

• The achievements in 2021-22 and the key initiatives of 2022-23 were shared by service teams. The major work progress of the service development and the draft annual plan of 2022-23 were also illustrated. (Refer to appendix). Members suggested to focus on the manpower shortage in wider scale, instead of the caring staff only. Members preliminarily approved the annual plan.

Service Focus and Plan

(Rehabilitation Services)

Major Achievements in 2021/22

(1) RPP Task Force

A task force group for RPP implementation monitoring among seven networks formed to speed up the development of rehabilitation services.

Each network commented and gave suggestions on designated strategy recommendation in the new RPP, comments and recommendations will also be discussed in the Task Force. Follow up actions will be discussed in 22/23.

(2) Follow up on the FSA of Employment Services for Persons with Disabilities

(2.1) Data collection on open employment of Supported Employment services

As open employment service was in difficult situation in past years, we've collected sectors' views and relevant data twice last year and reflected all findings and analysis to SWD.

(2.2) Meeting with SWD

In order to facilitate the communication between the representatives of Employment Network and SWD, a meeting was held on 10 November 2021. 32 sector representatives participated in the discussion and expressed their concerns on the output and outcome standards of FSA of the employment services on Supported Employment, On the Job Training (OJT) and Sunnyway (SY). In response, SWD clarified the definition of "Post-placement Service" and finally agreed to revise the output standards of capacity of post-placement service and the outcome standard of open employment on OJT and SY, etc.

(3) Care Givers Program

(3.1) Give a Hug" Care Givers Media Campaign

Care givers face tremendous pressure in carrying out their caring duties. In order to promote care giver service and address the needs of care givers to the public, a public media campaign called "Give a Hug were launched. More than 10 videos and texts were posted in Facebook and IG since May 2021.

(3.2) Carer Day

On 3 October 2021, Carer Day was organized to mobilize 16 NGOs from elderly, family and rehabilitation sectors to organize parallel groups for the care givers and their care recipients. The program aims at providing respite space for care givers to release stress from their caring duties. There were 281 care givers and 266 care recipients participated in the program.

(4) GIES Smart Tech Sports Day for People with Disabilities

Smart Tech Sports Day for People with Disabilities held on 05-Nov-2021 in GIES has been successfully completed. The event invited a total of 150 participants from REH sector with all types of disabilities to enjoy and experience having sport activities using Gerontech in a relatively small indoor area with little setting in venue.

(3) International Day of Persons with Disabilities 30th Anniversary Celebration Objective

- To increase public awareness, understanding, acceptance of people with disability
- To remind everyone that persons with disabilities are not to be left behind even after the crisis of COVID.

Deliverables

- To organize events and activities with support of 18 districts
- To promote social inclusion by engaging the business sector

Service Focus and Plan (Family and Community Service)

Major Achievements in 21/22

1. 賽馬會「你」想家長培力計劃 (JC Project IDEAL)

- Aim of the project: engage various stakeholders from different sectors to promote transformative parenting
- With 10 NGO platforms, 40 sets of educational materials would be prepared and expected to reach 80,000 parents.
- Practice sharing programs with 250 attendances would be conducted to further disseminate the practical experience in using the transformative learning approach.

2. 「集盒」計劃 (NGO Innovation Hub)

- This initiative kicked off in 2021. 10 agencies were benefited from 30-sesison professional consultations and 3-session workshops offered by HKBU.
- A documentary about creation of co-learning cycles among NGOs and use of CD practice in services would be made for further promotion.
- A local seminar is planned to be organized for consolidating the achievement the first quarter of 2022.

3. Ethnic Minorities District Ambassador Scheme

- 3 capacity-building events with 94 participants, and 2 publicity campaigns have been organized for the Scheme.
- Through the Scheme, a social service map, a service model and a work protocol are being developed to advance the sector's overall competency in serving EM.

Service Focus and Plan

(Children and Youth Service)

Key initiatives of 2022/23

(1) Proposed Mandatory Reporting Requirement for Suspected Child Abuse Cases: Government's Schedule

- Mid/ Late 2022: Sector consultation on the reporting mechanism, including route & threshold of reporting, concrete indicators of reporting threshold, corresponding change in procedural guide and development of reporters' guide.
- 2023 1st quarter: Legal proposal ready for public consultation.
- Pre-legislation: SWD's basic training courses on child protection are put online for access to all related professionals (training contents are based on the existing procedural guide).
- 2023: Finished legislation.
- 2023 (don't know when): SWD will form a multi-disciplinary workgroup to discuss the needs of related professionals and follow up matters. (Similar to the workgroup formed to review the procedural guide before, in which HKCSS & service reps were involved.)

(2) Enhancement of Child Protection Main purpose(s):

- To engage operators of children and youth services to prepare for challenges regarding the proposed legislation of mandatory reporting for suspected child abuse cases
- To enhance the professional capacity of practitioners in identifying cases of suspected child abuse and to make reporting decisions.

Deliverable(s):

- Meetings and focus group discussions organized to engage concerned practitioners.
- Recommendations made on the enhancement of child protection services and relevant tools to assist mandated reporters to make reporting decisions.

(3) Youth Mental Health: Advocating for enhancement of psychosocial support Main purpose(s):

- To engage operators of children and youth services (including school social work service, integrated children and youth service, etc.)
- to delineate the psychosocial needs of children and youth with mental health issues and existing service gaps
- to share practice wisdoms in rendering youth-friendly psychosocial support to children and youth with mental health issues
- to enhance mental health professionals' understanding of the benefits of psychosocial support for users, effective ways of working with youth and concerned role of social workers.

Deliverable(s):

- Focus groups with social workers from school and community-based children & youth services will be conducted to discuss the psychosocial needs of children and youth with mental health issues, service gaps, ways to refine the Student Mental Health Support Scheme (SMHSS) as well as sharing of practice wisdoms.
- Recommendation on improvement of the SMHSS will be developed and continued dialogues with other mental health professionals will be conducted to effect systemic and sustainable change.

(4) To address the mental health needs caused by the social unrest and the pandemic of

COVID-19

Main Purpose:

• To address mental health needs of the public by harnessing expertise of care professionals, including social workers, teachers, psychologists, and psychiatrists.

Deliverable(s):

- Continuation of the Time to Heal Project to provide emergency psychological and psychiatric support to those in need will be subjected to the availability of additional funding.
- Training and capacity building programs for care professionals.
