# 1 Welcoming and Introduction

Mr. Raymond Lai, on behalf of HKCSS, welcomed new members to join the Committee.

# **2** Terms of reference of the Standing Committee

The paper of Terms of Reference of the Committee was tabled for members' information.

# 3 Election of Chairperson, Vice-Chairperson and representative to Council Exco

Ms Yvonne CHAK and Ms CHOW Mee Tim were elected to be the Chairperson and Vice-chairperson respectively. As. Ms Chak is the present ExCo member, Ms Chow was appointed as the representative of our Committee to join the Executive Committee of HKCSS.

#### 4 Nomination of co-opted member for 2019-21

Mr. Stephen Sui was nominated as the co-opted member of our Standing Committee in coming 2-year term. Raymond would follow-up to confirm with him.

(Post-meeting note: Mr. Stephen Sui accepted the invitation to be the co-opted member of Standing Committee on Service Development).

#### 5 Declaration of interest

According to the governance and accountability of the Council, all committee members were required to declare the potential conflicts of interests. Members were reminded to complete the necessary procedure shortly and requested to submit one signed declaration form only if they joined more than one committee.

#### 7 Matters arising

# 7.1 LRC's Consultation Paper on Causing or Allowing the Death or Serious Harm of a Child or Vulnerable Adult (沒有保護罪)

The consultation paper was submitted to the Law Reform Commission of Hong Kong (LRC) in October. The paper was tabled and introduced in the meeting. Members were encouraged to further discuss and observe the progress at specialized committees. Due to the complexity and suitability, LRC was recommended to further discuss the subject to the welfare sector in future

# 7.2 Task group on manpower shortage

The report of the Manpower Shortage Survey was received in mid-November and the summary of result was highlighted in the meeting. Based on the previous practice, a briefing session would be conducted to release the findings to the concerned service

operators. Based on the survey and the submission of WAPS before, the Task Group on Manpower Shortage would further review the short-term and long-term strategies to respond to the manpower shortage issue, including the exploration of importation of foreign labor. Members were invited to join the task group.

# 7.3 End-of-life care legislative proposals regarding advance directives and dying in place (預設醫療指示和病人在居處離世的晚期照顧立法建議)

The proposed ideas of the End-of-life care legislative proposals regarding advance directives and dying in place was highlighted in the meeting. Based on the frontline experience and observation, many elders expressed their will that they would like to complete their life journey with dignity in their preferable environment when they are facing with the life-threatening health conditions. Due to the fast growing aging population in the coming decade, a holistic and integrated end-of-life care strategy should be developed. One-stop palliative and holistic care for elders and their families should be provided in the residential home setting. The strategic collaboration between the government, medical and social sector should be strengthened. Besides, appropriate manpower infrastructure with competent multi-professional staff team should be developed.

#### 8 For discussion

# 8.1 Progress update and response to the Proposed Amendment to the Fugitive Offenders Ordinance

The progress of "Time to Heal" project was highlighted. All eligible applicants were recommended to apply for the program and seek support from professionals. Several observations were highlighted in the meeting

- (a) Manage emotion: frontline social workers were depressed and frustrated due to the social unrest. How to manage their negative emotions?
- (b) Rebuild social relation: social bonding was weakened. How can we rebuild trust in the society and family?
- (c) Handle generational conflict: there was growing tension between family members. We had to strengthen family relationship and prevent family breakdown.
- (d) Recognize the role and duties of social worker: We should sent appeals to the government as well as the public, asking for recognition of social worker's role and their duties in solving social conflicts and providing assistance services to our clients during social movements such as the one of protests and demonstrations over the amendment bill to the Fugitive Offenders Ordinance.

# Members suggested some recommendations:

- (a) To build a communication and collaboration platform for better communication
- (b) To strengthen the competence of social workers, especially emphasize social work

values and professional ethics

- (c) To advocate social worker's role and human rights
- (d) To raise concerns and difficulty of service agencies in maintaining normal services during the period to SWD, and request assistance such as extra resources required in handling manpower shortage arising from repeated transport disruptions and commuter chaos
