#### Introduction

The **Sustainable Development Goals (SDGs)** were launched by the UN in New York in September 2015. The SDGs provide a global framework for eradicating poverty and shifting the world economy onto a sustainable and resilient path.

The 17 SDGs and 169 associated targets build on the previous eight Millennium Development Goals (MDGs), and seek to complete what they did not achieve.

Although the SDGs' development process was led by UN Member States, it was a highly inclusive process with unprecedented involvement and support from the business sector. In order to implement and achieve the Goals, business action will be critical. This document seeks to explore the practical implications for business in the specific context of Hong Kong, with reference to a number of our key industries.

#### Sustainable Business HK

Sustainable Business HK was launched in 2015 to help move sustainability from concept to practice. We aim to support businesses to make a positive contribution to sustainable development through their core business activities.

Sustainable Business HK is an initiative of the Caring Company Scheme. The Scheme was established by HKCSS in 2002 to cultivate good corporate citizenship through building strategic partnerships between businesses and NGOs. Today there are more than 2,900 Caring Companies and Caring Organisations across a wide range of sectors.

This document has been developed with reference to existing business practices and guidance. All of the business actions suggested in this document are already being implemented by companies in Hong Kong and elsewhere.

## **Relevance to Business**

Many of the SDGs are relevant to companies across Hong Kong's major business sectors. Some examples are provided below, together with suggested actions and management approaches. Further examples and suggestions relating to specific sectors are provided in the following sections.

#### Provide guality education and life-long learning opportunities

- 4.4 By 2030, substantially increase the number of youth and adults who have relevant skills, including technical and vocational skills, for employment, decent jobs and entrepreneurship

# Manufacture, Trading & Logistics

Trading and Logistics is one of Hong Kong's four pillar industries, accounting for 23.9% of value added in GDP and 20.6% of total employment. Manufacturing and Trading is the largest category in the Caring Company Scheme, accounting for **7.4%** of awarded companies.

The range of products traded is diverse. Therefore, companies in this sector are able to influence outcomes across a wide range of supply chains and customer groups.

# Retail

The latest retail statistics for Hong Kong estimate a total monthly sales value of **\$35.2 billion**, with growing food and supermarket sales. Hong Kong retailers employ many local people directly, and have highly diversified, often international supply chains.

Retail is the third-largest sector in the Caring Company Scheme, accounting for 7.1% of awardees.



With 2.5 million domestic households and well over a million registered businesses in Hong Kong, demand for property and infrastructure remains high. Property and construction companies influence sustainable development through a number of touch-points, including employment, supply chains, and the types of communities they create.

Property Management is the second-largest category in the Caring Company Scheme, while Construction, Engineering and Interior Design ranks fifth. Property Development and Real Estate ranks fifteenth.

Financial Services is another of Hong Kong's pillar industries, generating 16.5% of value added and 6.2% of employment. Within the Caring Company Scheme, Banking, Financial and Credit Services is the fourthlargest category, accounting **5.1%** of awarded companies.

Financial institutions have significant capacity to influence sustainable development through both their products and the way in which they select or screen investees and borrowers.

In order to identify the most relevant issues and opportunities, we invite every company to assess how its business operations, employment practices, value chains and products/services might impact or contribute to each of the SDGs. This analysis can be used as a basis for setting sustainability goals and targets, engaging internal and external stakeholders, and establishing programmes and partnerships for change.

#### Leadership

At the sector level, we encourage industry and professional associations to establish or support in-depth analysis of the most relevant SDGs for their sector, with the involvement of major companies in the industry. For an example of how such an analysis might look in practice, we recommend viewing the UNGP-RICS toolkit, Advancing Responsible Business Practices in Land, Construction, Real Estate Use and Investment.
