過渡性社會房屋 - 誠邀提交業成街項目計劃書 事由:

2025年10月20日 日期:

在政府支持下,過渡性社會房屋政策已推行超過三年。過往三年,有不少居住在 不適切住房的家庭搬到過渡性社會房屋,改善生活環境。業成街項目於 2023 年1 月入伙,至今已服務超過150個家庭。

香港社會服務聯會將繼續營運業成街項目至少2年。計劃目標為正長期輪候公屋、 居住環境惡劣的基層市民,或受「簡樸房」規管制度相關的改造工程或執法行動 影響,並且有迫切短暫安置需要的分間單位住戶,提供有租約年期限制的可負擔 及過渡性社會房屋,以改善生活質素。在提供過渡性社會房屋的同時,計劃的重 點是注入社會服務元素,由社會服務機構或社會企業管理及提供社區網絡和支援 服務,協助基層住戶改變貧窮和社會孤立處境。

本會現誠邀認可營運機構提交項目計劃書,嘗試實踐有別於現時住宿服務的計劃, 特別在計劃中需要組織居民創造新的服務回應居民及社區需要。在項目進行期間, 營運機構需與本會合作,共同檢視項目的運作成效及社會影響,以探討社會房屋 服務的未來發展。請於 2025 年 11 月 21 日(星期五)下午 5 時或以前,親身或以郵 寄方式遞交計劃書至本會,地址為香港灣仔軒尼詩道 15號溫莎公爵社會服務大廈 13樓,計劃書應用信封密封,封面請註明:

Re: Modular Social Housing – Call for Proposals for Yip Shing Street Project

Date: 20th October, 2025

Under the support by the HKSAR Government, the policy of transitional social housing has been implemented for more than 3 years. In the past 3 years, the living conditions of many households have improved after moving to transitional social housing. Since the move-in of Yip Shing Street Project ("Project") in January 2023, we served more than 150 households.

The Hong Kong Council of Social Service ("the Council") will continue to operate the Project for at least 2 years. The objective of the Project is, through the provision of transitional accommodation and support services, to improve the quality of life for those living in inadequate housing who are waiting for the public rental housing. It also provides transitional accommodation for those affected by alteration works in SDUs or enforcement actions under the Basic Housing Unit regulatory regime, who have an urgent need for temporary re-housing. While providing transitional social housing, the Project recruits NGOs/ social enterprises to manage and provide community network building and support services to improve residents' social capital and develop their capacity for living independently in the community.

We invite NGOs/ social enterprises to provide innovative social housing services and to become our recognized service operator to submit a proposal. Particularly, the proposal is expected to suggest a way to organize residents to create a new service in response to the needs of residents and the community. During the project period, the operator is also expected to work with the Council to evaluate the effectiveness and social impact, and to explore the long-term development of social housing service in Hong Kong. Please submit the proposal by 5pm on 21st November, 2025 (Fri) by mail or by hand to 13/F, Duke of Windsor Social Service Building, 15 Hennessy Road, Wanchai, Hong Kong. The proposal should be sealed with the title of the Project.
