The total number of unique visitors to the Knowledge Hub in the three-year project period is estimated to be 8,000. There will be a log-in portal for supplier side and demand side, where demand side may post their wish-list for supply side to post possible product/solution to meet such needs. The estimated number of registration at the portal(s) is 900.
QA2	10/9/2021	Please provide an estimate or past number of participants in Networking and Capacity Building section of the platform.	The scale of the Networking and Capacity Building activities varies from 15 to 300 participants for each activity, including online event. The total number of participants in the three-year project period is expected to exceed 2,400 and we are planning to have over 50 events in total. All of which would have at least a registration list, if not an attendance list.
QA3	10/9/2021	Please provide also the different types of capacity building initiatives and the number of participants	Networking and Capacity Building activities include but not limited to local and overseas study visits, annual summit, theme-based seminars /

		in each respective type of initiative.	workshops, briefings and trainings. The number of participants for each activity varies from 15 to 300. The scale depends very much on the location and nature of the event.
QA4	10/9/2021	Please indicate the number of products and/or companies that will be utilising the Consultancy, Localization and Testing support of the platform.	<p>The expected number of products and companies that will be utilising the Consultancy, Localization and Testing Support of the Platform in the three-years project period is illustrated as follows:</p> <ul style="list-style-type: none"> - For localization and testing support, we expect to handle over 100 companies which would have expressed interests in the testing support exercise during the three-year period. - Number of products shortlisted for testing at residential homes and centres; as well as community level will be around 10-12 in total. - For products grouped under companies that receive consultancy service, it would be difficult to estimate. Assuming one product per company receiving consultancy service, we planned to have about 240 companies to receive consultancy service in the 3-year project period, so that would cover about 240 products.
