本會於七月至今,已召開六場業界交流會,討論工作指引及相關文件,共有來自 93間超過400位高層及中層機構代表出席;同時,本會透過服務專責委員會及服務網 絡,收集機構意見。目前,本會已就工作指引包括(1)界定《協議》相關服務之服 務對象、(2)爭取非採取一概而論方式處理自負盈虧服務及社會企業性質這兩項服 務、(3)機構籌款活動及企業功能活動(4)機構使用外部資源並將其納入周年財務 報告、可追溯文件與會計檢查,以及交代等等範疇的處理原則,持續與社署進行討論。

I write to cordially invite you to attend the Agency Heads Meeting for subvented Agency Members to be held on 21 September 2023 (Thursday), 9:30 am at Room 202, 2/F, Duke of Windsor Social Service Building, 15 Hennessy Road, Wanchai, Hong Kong to discuss some updates on "Operational Guidelines on Funding and Service Agreement-related Activities and Cost Apportionment for Nongovernmental Organisations".

Since July, we have organized six exchange sessions to discuss the Guidelines and related documents. A total of over 400 senior and middle-level representatives from 93 organizations attended. Additionally, we have collected feedback from Subvented Agency Members through our Service Committees and Networks. On the other hand, we have been engaged in ongoing discussions with Social Welfare Department regarding the principles of various aspects of the Guidelines. These aspects include (1) Defining the target beneficiaries of the FSA-related activities, (2) Advocating for a non-generalized approach in handling self-financing services and social enterprise, (3) Fundraising activities and corporate functional activities of organizations, and (4) Organizations utilizing external resources and recording them in Annual Financial Report, documentation, accounting inspection and accountability issues.

In the coming Agency Heads Meeting, we will share key progress of the SWD's implementation of the "Review Report on Enhancement of Lump Sum Grant Subvention System". We highly encourage the attendance of heads at the meeting and warmly welcome input and opinions from Agency Members.
